

Terms of Use for the Common Use Lounge

1. General

- 1.1 These Terms of Use apply to the Common Use Lounge at Berlin-Tegel Airport. Unless otherwise stipulated in the Terms of Use, the terminal regulations of the Berlin-Tegel Airport apply in their current version.
- 1.2 The Common-Use Lounge is open from 06:30 to 21:30 (local time)
- 1.3 Use of the Common-Use Lounge includes the following services:
 - Seats - Seats are available for your stay based on availability and capacity utilization. A claim to a seat does not exist.
 - Food and Beverages - During your stay, a range of food and beverages is provided for consumption in the lounge. A claim for certain food and drinks does not exist.
 - WiFi - Free Wi-Fi access is available throughout the common-use lounge.
- 1.4 The admission is limited to three hours.
- 1.5 The Common-Use Lounge is located after the security check in the Schengen area. Passengers with a departure destination to a Non-Schengen Country must allow sufficient time for border control prior to boarding gate entry.
- 1.6 The display of flight times is without guarantee. Passengers are obliged to keep themselves informed about their boarding and departure times.

2. Admission

- 2.1 Access to the Common Use Lounge is only available to passengers departing on the same day.
- 2.2 Guests have access to the Common Use Lounge with their boarding pass with appropriate authorization. In addition, each passenger can purchase an access in accordance with the regulations under point 3.
- 2.3 The airport operator reserves the right to deny access to the common-use lounge, in particular if the lounge cannot be opened due to force majeure, strike, construction or governmental measures, or if the capacity does not allow further admittance of passengers.

3. Fee & Payment Terms

- 3.1 For the use of the Common-Use Lounge, a fee according to the "Fees for miscellaneous services" on our website is payable.
- 3.2 The General Terms and Conditions of the Charges for Other Services apply. Deviating from point 1.4 of the payment regulations, the airport operator reserves the right to insist on a credit or debit card.

4. Data Protection

- 4.1 For the purpose of contract execution, the airport operator collects, processes and uses certain personal data.
- 4.2 Once the purpose of data collection, processing or use has expired and no further legal basis for processing continues to exist, the personal data stored by the airport operator will be deleted in accordance with the law.

5. Liability

- 5.1 Liability for the loss of luggage or other personal belongings is excluded.
- 5.2 Liability for minor negligence or gross negligence of the airport operator or a subcontracted agent is limited to the typical, foreseeable damage in the case of a breach of a material contractual obligation, in other cases excluded. The fault liability for damage resulting from injury to life, limb or health remains unaffected.
- 5.3 The airport operator is not liable for damages caused by force majeure or other causes for which it is not responsible, such as official intervention or incorrect information about the order details (departure or arrival times, connecting flights, flight destinations, etc.).

6. Others

- 6.1 The airport operator reserves the right to change these Terms of Use, Charges, Facilities and Services and opening times at any time without written notice.
- 6.2 The place of performance and jurisdiction for the obligations and legal disputes arising from these Terms of Use is Berlin. German law applies.
